



A common definition -

Reset: Actions taken to restore units to a desired level of combat capability commensurate with the units' future mission. It encompasses maintenance and supply activities that restore and enhance combat capability to unit and pre-positioned equipment that was destroyed, damaged, stressed, or worn out beyond economic repair due to combat operations by repairing, rebuilding, or procuring replacement equipment. These maintenance and supply activities involve Depot (Sustainment) and Field Level (e.g., Organizational and Intermediate) repairs/overhauls centrally managed to specified standards. Included are Procurement, RDT&E, and Operation and Maintenance funded major repairs/overhauls and recapitalization (Rebuild or Upgrade) that enhances existing equipment through the insertion of new technology or restores selected equipment to a zero-miles/zero-hours condition.

SUBJECT: Establishment of OSD Materiel Readiness Committee

The Department, Combatant Commands, and Services are collectively operating at an increased operational tempo due to the Global War on Terrorism. To provide decisions for critical time sensitive issues directly affecting the support of the war effort, OSD will establish the Materiel Readiness Committee. It will provide a single point of entry into the Department for the Combatant Commands and Services, to address critical war-related materiel readiness issues requiring OSD or higher response or approval. The objectives are:

- Effective support of changing logistics requirements supporting the war fighter.
- Efficient and effective RESET of forces, including issues related to transportation, acquisition, procurement, and maintenance activities.
- Accelerating readiness and cost effectiveness.
- Proper stewardship of resources.

The Committee will address those critical issues presented by the Combatant Commands or Services that require expedited handling and accelerated presentation to senior officials. It will anticipate authorities or flexibilities required for future materiel support. The use of the Committee is not mandatory for all issues, and is not intended to

supplant the normal staffing process. It will focus only on selected, critical, war-related, time-sensitive actions requiring immediate senior leader involvement. The Committee will specifically address:

- Issues that require a change to DOD policy or waiver.
- Obtaining or invoking emergency authorities already available at the Department or executive level.
- Legislative authorities.
- Administration approval.

The committee will be co-chaired by the Deputy Under Secretary (Logistics & Materiel Readiness) and the DoD Deputy Comptroller. It will function under the oversight of the Under Secretary of Defense for Acquisition, Technology, and Logistics, who is responsible for approving Committee composition and procedures.

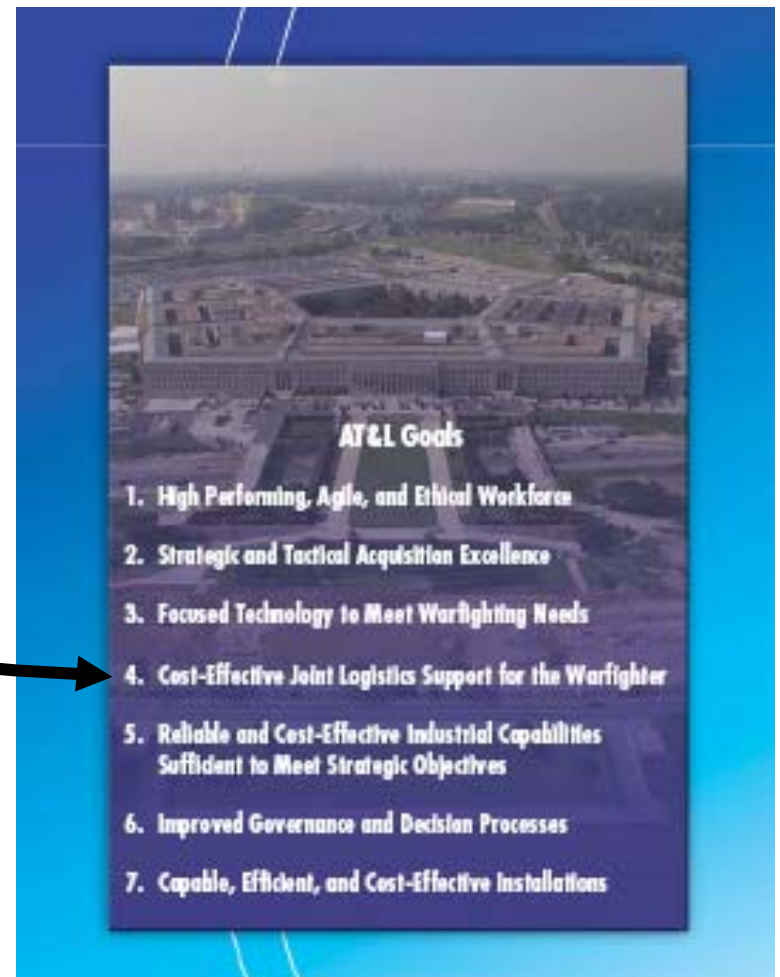
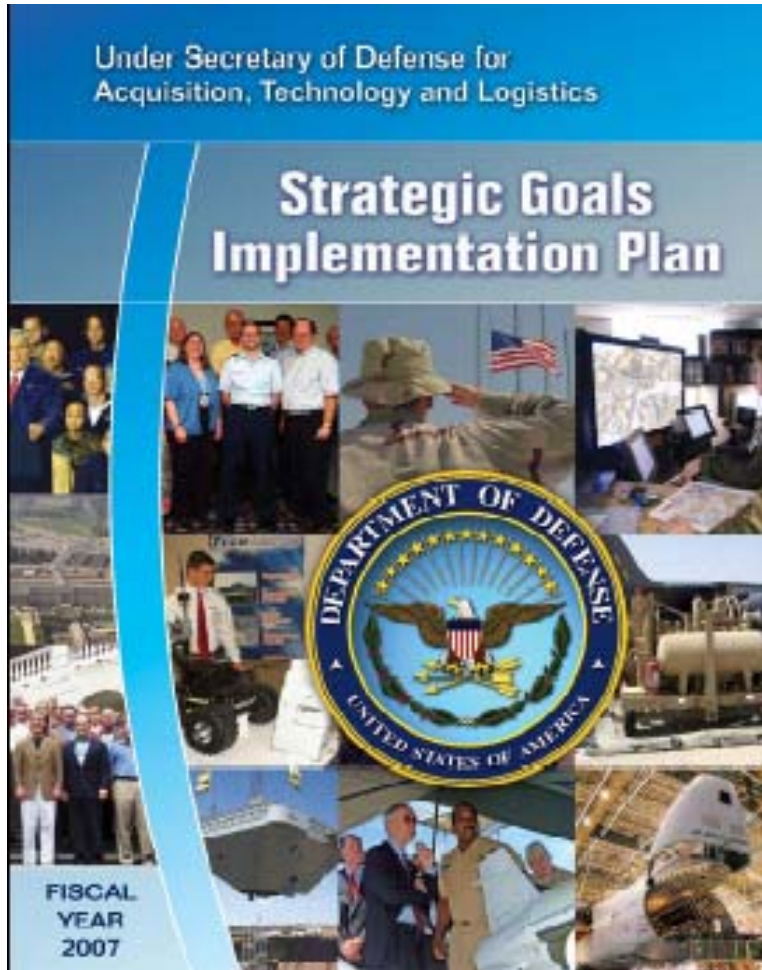
