Background

- 2013 National Defense Authorization Act
 - Secretary of Defense designated a Small Business Ombudsman (focal point) within DCAA and DCMA
- Strategic Plan Goal 4 - Effective working relationships with DCAA external stakeholders
 - Appointed a Small Business Focal Point and implemented a Small Business Outreach Program

Small Business Focal Point

- Duties segregated from ongoing audits so as to avoid compromising independence
- Working with DoD Offices of Small Business Programs
- Responsible for seminars for small business contractors

Initiatives Affecting Small Business

- Incurred cost Inventory
 - Dedicated audit teams
 - Low risk sampling
- Preaward Accounting System Checklist implementation

Small Business Outreach

- Web site tools (Checklists, ICE, etc.)
- Coordination w/small business offices at major buying commands (FLAs)
- Presentations at seminars/workshops
- Presentations for small business on Web site
- NDIA/SBTC joint DCAA/DCMA committee meetings quarterly to discuss small business issues
- Mandatory auditor small business training

Preaward Accounting Systems

- FLA Recommended Approach
 - PCO sends a letter to the contractor explaining the FAR/DFARS requirements for an acceptable system, and has contractor complete and return a Preaward Survey of Prospective Contractor Accounting System Checklist
 - PCO provides the contractor's completed checklist to DCAA with the request for audit
- Benefits:
 - Contractor is aware of the requirements of an acceptable accounting system and has asserted it complies with them
 - Contractor is prepared for the audit
 - Faster turn around
 - Less rework by contractor and auditor
 - Quicker contract award
