SMCA: Responsibilities of the SMCA and Military Services

SMCA Objective:

- Achieve the highest possible degree of effectiveness and efficiency in the DoD operations required to acquire conventional ammunition and integrate logistics functions for U.S. Forces
- Annually identify and prioritize production base deficiencies and formulate corrective actions to mitigate those deficiencies.
- Execute the direct appropriations for the Production Base Support program for munitions
 - Provision of Industrial Facilities (PIF), Layaway of Industrial Facilities (LIF), Maintenance of Inactive Facilities (MIF), Armament Retooling & Manufacturing Support (ARMS)
 - Procurement of Ammunition, Army (PAA)

Authorities in the James M. Inhofe NDAA FY2023-Temp Authorizations for Contracts Related to Ukraine



\$20B+ in security assistance to Ukraine since Feb 2022

- 1. Exception to full and open competition (if in public interest)
 - Eliminates requirement for written Justification & Approval
- 2. Waiver of limitations associated with Undefinitized Contract Actions (UCA)
 - Allows greater than 50% obligation w/out a qualified proposal
- 3. Exemption of Certified Cost & Pricing for certain contracts
 - Applies to Fixed Price Incentive Firm Target contracts
- 4. Allows sharing of Large Caliber Cannon Technical Data Packages
